### **Transport** Reminder

Changes to Transport arrangements for Participants



Wednesday, 2nd January should now reflect your Transport arrangements. We

As you are aware there has been some changes to the way transport can be funded under the NDIS- in particular this relates to the conversion of Kilometres travelled while transporting participants. Families are no longer able to use their core funding to pay for kilometres travelled unless the person has transport as a stated support in core supports.

In the absence of this stated support in the core section, participants are expected to pay for km's travelled in workers/Interchange vehicles. For those participants who are over the age of 16 and cannot access public transport, the NDIS may have included transport as a separate category in the persons plan. This replaces the Centrelink mobility allowance and is paid directly to the participant/ carer. The NDIS expects participants to use these funds to pay for mileage incurred during supports i.e. Interchange will invoice families for mileage and they will use their transport allowance to pay the invoice.

This is a big change and your amended Service Agreement

will have to cease all km's converted to core before 31st December 2018.

It is critical that you have discussed transport limitations with your Support Workers to avoid receiving a large unexpected transport bill.

For those of you that have chosen to continue transport, and do not have transport in your NDIS package, invoices will be issued by Interchange each pay period and are due for payment within 14 days of invoice date.

## NEED TO ASK A QUESTION? YOU CAN TALK DIRECTLY TO THE CEO

At Interchange Illawarra the safety and well-being of the people we support is paramount and that is why you can pick up the phone and talk to a real person if you have any concerns.



All Staff who work with Interchange must have a current Working With Children Check as well as a National Police Check. First Aid Certificates are also mandatory.

Interchange has a Code of Conduct that emphasises our values and standards and this must be signed by everyone that works for us.

As accredited Providers we are bound by the NDIA Quality & Safeguards Commission regulations as well as our own conscience to provide a service that people can trust. We have introduced Mandatory Online Training that must be completed before a Support Worker undertakes their first shift.

We have clear guidlelines for reporting and handling complaints and reporting criminal activity to appropriate authorities.

If you ever feel you need further clarification on our processes we have in place to ensure your or the person you care for's safety please call Jake our CEO on 4227 1079 who will address your concerns.

### **Not your typical Social Support Group**

Specifically for children between the ages of 4-12 years old with autism and challenging behaviours.

Interchange Illawarra has been running the Saturplay Program for over 20 years.

This Program is a one of a kind within NSW and is run by experienced coordinators, workers and volunteers with specialised training.

The Program encourages
Participants to access a wide
range of community based
activities, as well as providing
a program of enriching centre
based activities to support
development of communication,
social skills, sensory and
emotional regulation. The centre
based group structure ensures
that the Participants receive
the benefit of developing and
practicing their social skills in
a supported environment with

the opportunity to develop meaningful relationships with peers.

Saturplay is held on a Saturday at the ASPECT South Coast School, Corrimal based site. This is perfect for supporting Participants with its specialised facilities and some sharing of expertise with some staff working at both Saturplay and ASPECT.

It is without a doubt that everyone that engages with the Saturplay program benefits from the relationships fostered and the mutual understanding and shared successes enjoyed by Participants and workers alike.


